MOTION FOR CONTINUANCE OF EVICTION HEARING

Now come Defendants Viacheslav Kovalkov and Larisa Kovalkova, by and through their attorney, and respectfully request the Court to continue the eviction hearing until after November 9, 2023. As set out in the attached affidavit, Defendants purchased nonrefundable airline tickets to Kirkenes, Norway on approximately September 12, 2023. At that time, Plaintiff had not requested an eviction hearing in this matter. Defendants are traveling to Norway in order to enter Russia. The goal from there is to enter Ukraine or get to the Ukraine border in order to move family members from Ukraine into Russia. Defendants are leaving October 4 and returning on November 9, 2023.

After Defendants purchased the tickets, Plaintiff requested an eviction hearing and the Court scheduled the hearing for October 25, 2023. Defendants will be out of the country until November 9, 2023 for the purpose of helping family members leave Ukraine. The requested delay is minimal and Plaintiff has had since June 22, 2023 to request an eviction hearing but let more than three months pass before finally doing so. Counsel for Plaintiff has also indicated that Plaintiff would be unable or very unlikely to participate in person on October 25, 2023 so a continuance would also allow Plaintiff to fit the eviction hearing into her busy schedule. For these reasons, Defendants

respectfully request that the Court continue the scheduled hearing until after November 9, 2023.




